It is for the information of those students who have taken admission in B.Ed. course for the year 2023-24 in Blooms College of Education, Village Kot, P.O. Chunahan Tehsil Balh (Sundernagar) Distt. Mandi H.P. which is being run by the Blooms Education Society that the interim relief granted to the said college for participating in counselling for admission to B.Ed. course in the Civil Writ Petition No.9031/2023 on 22.11.2023 stands withdrawn, expunged and vacated in its decision on 28.12.2023 by the Hon'ble High court of H.P.

Therefore, it is made clear to the students seeking admission and who have sought admission in the aforesaid course in the Blooms College of Education, Village Kot, P.O. Chunahan Tehsil Balh (Sundernagar) Distt. Mandi H.P. that there is pendency of litigation regarding recognition from NCTE against the aforesaid institution and accordingly their admission shall abide by the final outcome of the writ petition No. 9031/2023 and the students shall not claim any equity at least against SPU Mandi.

Apart from that it is also pertinent to mention here that the Blooms College of Education, Village Kot, P.O. Chunahan Tehsil Balh (Sundernagar) Distt. Mandi H.P. has been debarred from attending counselling for admission to B.Ed. course for the session 2024-25 by the NCTE.
