Subject: Regarding Recommendations of Curriculum Committee.

Sir/Madam,

It is to inform that the Curriculum Committee constituted under the Chairpersonship of undersigned has worked on the various representations received from affiliated institutions. The different meetings of Curriculum Committee were held to remove the anomalies of curriculum of all the courses being run in the affiliated colleges of SPU and various subject experts were also involved in this process. The recommendations made by the Curriculum Committee are:

1. In the 1st Semester of session 2022-23 the syllabus of HP University (approved vide Board of Studies held in June 2022) was followed by Sardar Patel University Mandi. Accordingly, the examination of 1st semester has been conducted in the month of December, 2022.

Himachal Pradesh University, Shimla has changed the syllabus in certain disciplines in its Board of Studies held in November, 2022 and this curriculum was made effective from the session July, 2022 onwards.

Accordingly, Sardar Patel University Mandi adopted the new syllabus as approved in November, 2022 & Notification in this regard has been issued by the Sardar Patel University Mandi vide reference No. SPU-Mandi/Acad/2023-114 on dated 23.05.2023.

But in 1st semester the examinations had been already conducted on the basis of HPU BOS/June /2022. So the following changes are required in the case of students of Batch 2022-2023:

1.(a) M.Com.:

For the batch of 2022-2023 the students have already studied MC107 and this subject they will not study in 3rd semester. The score / credit of this course will be reflected in the detail marks card of 3rd semester. The credit of the course will be of 4. For reappear students of batch 2022-23 this course will be now attempted in 3rd semester.

1.(b) MA Economics:

For the batch of 2022-2023 the students have already studies ECON-115. So, they will not study and appear for ECON-236 in 3rd Semester hence, their score / credit of ECON-115 will be considered and will be reflected in 3rd Semester instead of 1st Semester. The code MEC will be replaced by ECON in the already passed 1st semester to make similarity with other students. For next batches the new syllabus will follow.

1.(c) MA Hindi:

For the Course Code MHIN305 it is an enhancement of ability and no external paper will be of this paper. As per the analogy of English course the pattern of Evaluation will be Mid Term – 40 Marks, Before End term exam – 40 and Assignment – 20 total = 100 marks.

1.(d) M. Sc. Industrial Chemistry:

For batch 2022-2023 the old syllabus will continue and for the batch of 2023-2024 the new syllabus will be continued.

1.(e) M. Ed.:

The subject MED104 will be in 4th Semester as per new syllabus. So the code will be MEDE204. The students of batch 2022-2024 will not study this in 4th semester as they have already studied it in 1st Semester, therefore, their score of 1st semester will appear in the 4th semester. For batch 2023-2024 the new syllabus will follow.

1.(f) BPED:

The credits shown in the syllabus for the course code BPED-TP-0110, BPED-TP-0210, BPED-TP-0310 & BPED-TP-0410 are not given in the DMC of HPU. But the expert recommended that the DMC should be as per scheme and there will be total credits of 136 for this course.

1.(g) BPE:

The subject of 4th semester named as Music Practical Course Code BPE-P-0412 will be of Practical and there will be no theory paper of the same. The credit for this course will be 1 Credit. The pattern of Scheme i.e. CCA and ESE will be of 50:50 Marks. The Compulsory Courses Hindi, English and Environmental Science will be of 3 Credits each having total 75 Marks (ESE=50 and CCA=25).

1.(h) B. Voc. (Retail Management):

The Course Codes OJPTR-01, OJPTR-02, OJPTR-04 and OJPTR-06 will be given to On Job Practical Training and Report of 1st, 2nd, 4th and 6th Semester under the Skill Component, respectively. These may be changed in Examination Scheme.

1.(i) B.Voc. (Hospitality and Tourism):

The Course Codes OJPTR-01, OJPTR-02, OJPTR-04 and OJPTR-06 will be given to On Job Practical Training and Report of 1st, 2nd, 4th and 6th Semester under the Skill Component, respectively. In 2nd Semester the Course Code EN211 of Subject Tourism Products and TH212 of Subject Communicative English for Tourism and Hospitality will be TH211 and EN 212. These may be changed in Examination Scheme.

1.(j) In rest of the course the schemes have been checked and modified.

Henceforth, all codes will be followed of new syllabus i.e. vide notification No. SPU-Mandi/Acad/2023-114 dated 23.05.2023 issued by the SPU. Only for the batch of 2022-2023, July /December semester the code used were different. The detail marks certificate will be amended accordingly and for re-appear all such students will appear under new codes. The code of new syllabus will be adopted in all courses.

2. All the Schemes of each curriculum have been checked and with the help of subject experts all the credits etc. are corrected. These schemes will be followed in the letter & spirit in all the academic /examination activities.

The approved copies of curriculum will be uploaded on the official website of the university soon. All concerned are requested to follow the curriculum made available on the official website of the university.
