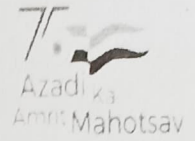

Instructions for Counselling:

1. Candidates must bring their original certificates/documents (10th, 12th, B. Sc., Character certificate, Bonafide, Category, Entrance score card, etc.) for verification.
2. Candidates failing to appear for counselling will have no claim for seat allotted.
3. For subsidized seats, Full fees must be deposited on same day of counselling i.e. 02/08/2022. The description of fee is mentioned in the prospectus which is uploaded on the web site: <https://svpcumandi.ac.in>
4. For Non-subsidized seats, amount of Rs. 10000/- must be submitted on the same day of counselling (02/08/2022) for the confirmation of seat allotted.
5. Fee can be deposited through ONLINE MODE or CHEQUE in favour of FINANCE OFFICER SPU, MANDI in the SBI account No. 39825240539, IFSC code SBIN0010326.
6. Candidates have to submit or send the fee receipt/UTR No. by hand or via email: spumandiphysics@gmail.com
7. Students, who fail to deposit the fee by due date/time, will lose the right to admission.
8. Any anomaly in the merit list will be settled on the day of counselling.
9. The candidates who have applied for the counselling-cum-admission for the single girl child are also required to attend the counselling on 02-08-2022 and the admission will be done on the basis of the merit of entrance test.
10. The seats remained vacant in subsidized category on the date of counselling-cum-admission will be allotted from the candidates appeared in the non-subsidized category based on the merit of the entrance test score.
