## 2. Mode of Payment:

The desirous & eligible candidates shall have to pay required application fee through online modes (i.e. internet banking, UPI etc) as the case may be, on or before the prescribed closing date for the submission of online application.

# 3. Parameters for Screening/Selection:

All applications shall be screened by duly constituted Screening Committee for determination of eligibility of each candidate. Incomplete applications shall be rejected summarily. No correspondence in the regard shall be entertained. The academic score component as specified in Appendix II (Table 2 & 3A) of the UGC Regulations, 2018 as amended from time to time for the post of Professor, Associate Professor, Assistant Professor respectively shall be used only for shortlisting of applicants for interview. The selection shall be based only on the performance in the interview, as per Notification No. SVPCU-Mandi/35/Academics/2020-1873-81 dated 30<sup>th</sup> April, 2021.

## **IMPORTANT INSTRUCTIONS:-**

- 1. The candidates must read the INSTRUCTIONS CREFULLY before uploading the information on Online Application for the relevant post(s).
- **2.** Date for determining eligibility of all candidates in respect of essential qualification(s) and experience, if any, etc. shall be the prescribed closing date for submission of Online Application i.e. **17.11.2022.**
- 3. The candidates are advised to keep the USER ID and PASSWORD, as the same will be applicable for all future reference.
- 4. The candidates(s) is also required to submit hardcopy after downloading in online application form along with requisite relevant documents in support of the information uploaded in the online application. The separate hardcopy along with all the requisite documents for each post(s) should reach in the University on **02.12.2022** upto 05.00 p.m. However, the candidate residing in Andman & Nicobar Islands, Lakshadweep, Ladakh, Assam, Tripura, Meghalaya, Nagaland, Manipur, Mizoram, Arunachal Pradesh, Pangi and Bharmour Sub Division of Chamba District, Dodra Kwar Sub Division of Shimla District, Kinnour Districts and Lahual & Spiti Districts of Himachal Pradesh, the last date for receiving of hardcopy of online application form shall be **08.12.2022** upto 5.00 p.m. The University will not be responsible for any postal delay. The hardcopy of the online application form alongwith all relevant documents should reach in the office of the **Registrar, Sardar Patel University, Mandi -175001** on or before the above prescribed the last date of submission of hardcopy.
- 5. The candidate before applying must ensure that they are eligible according to the criteria given in **UGC Regulations 2018**. If the candidate is found ineligible at any stage or hide/suppress the information or furnished the false information, his /her candidature will be cancelled at any stage of the recruitment process and shall also be liable for legal action in accordance with law.

- 7. If the candidate wants to apply for more than one post, separate application form is required to be filled.
- 8. The candidates must fulfil the required essential educational Qualification(s) / Experience and other conditions before the closing date of online portal as mentioned in the advertisement to avoid disqualification.
- 9. The benefit of reservation for various post(s) will be admissible only to the candidates, who are Bonafide residents of Himachal Pradesh in respect of categories, viz. S.C., S.T., O.B.C., E.W.S. B.P.L., Ex-Servicemen, W.F.F. and Persons with Benchmark Disabilities. The candidates are required to submit certificate in support of the claim of her/ his category as prescribed by the State Govt. from time to time.
- 10. Candidates claiming reservation under EWS (Economically Weaker Section) shall have to submit "Income and Asset Certificate" in respect of their family, duly issued by the competent authority on the prescribed format as specified in Department of Personnel's (State Government of HP) along with their application form on or before the closing date of receipt of applications in this advertisement, failing which their application will not be considered.
- 11. The appointment of the EWS category applicant shall be provisional and subject to the Income and asset certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake/false the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of fake/false certificate.

- 12. In case any Economically Weaker Section (EWS) candidate is not available for selection the post will be treated automatically as de-reserved and will be filled up from a non- EWS candidate of Un-Reserved category.
- 13. Candidates claiming reservation under the Benchmark Disability as per the Department of personnel, Govt. of Himachal Pradesh notification No. PER(AP)-C-F-4-1/2020 dated 22<sup>nd</sup> June 2020, the order of preference will be as follows: (a) Blind and low vision, (b)Deaf and hard of hearing, (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy (d) Autism, intellectual disability, specific learning disability and mental illness Multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness.
- 14. The category of the candidate claimed in the online application for the relevant post shall be treated as final. In case his/her category undergoes a change before the prescribed closing date for submission of online applications, then the candidate shall have to cancel his /her previous application and have to apply afresh under the category which he/she intends to claim after updating category in his /her application. In such a situation, the fee deposited by the candidate earlier shall stand forfeited and he/she shall have to deposit fresh fee as is applicable for the category claimed by him/her.
- 15. In-service candidates must submit their hardcopy though proper channel. However, advance copy of the same may be submitted as per schedule mentioned above.
- 16. The candidates called for interview shall have to essentially report with the original documents in support of their claims in Online Application and as prescribed in the interview call letter failing which he/she shall not be considered for the interview. No TA/DA will be admissible for attending interview.
- 17. In case of any dispute, suits or legal proceedings against the University, the territorial jurisdiction shall be restricted to Hon'ble High Court of Himachal Pradesh, Shimla and District Courts at Mandi.
- 18. The University reserves the right to Revise/ Reschedule/ cancel/ suspend/Withdraw the recruitment process without assigning any reason. The number of post(s) is/are tentative and may increase or decrease from time to time.
