- Candidates who have cleared the UGC-NET (including JRF)/UGC-CSIR NET (including JRF)/SLET/GATE/teacher fellowship holder or have passed M.Phil program as per the UGC (Minimum Standards and Procedure for Awards of M.Phil/Ph.D Degree) Regulations 2016 are exempted from the entrance test and they can appear directly for the
