2. For Non- subsidized seats, full fees of the first semester (35000/- boys and 35000/- girls) must be submitted on and before **September 8th, 2023 (Friday) up to 5 p.m.** for the confirmation of seats allotted.
3. Fees can be deposited through online mode or by check in favour of finance officer SPU, Mandi, in the SBI account no. 39825240539, IFSC code SBIN0010326.
4. All the candidates are required to submit the original receipt or UTR number of fees to the department of management studies at SPU Mandi on or before the last date of submission by hand or via email: hodmanagement@spumandi.ac.in
5. Students who fail to deposit the fee by the due date or time will lose their right to admission.
6. In the event of any misrepresentation of facts or any discrepancy found in the documents supplied by the candidate, his or her admission is liable to be cancelled without any prior
